A plan/idea of your flash mob must be included with the registration form. (What will you be doing, your ideal location, how much space your mob would require, what props will you be using, will it be singing, dancing, etc.)

We would also be more than happy to come and discuss the idea with your organization at your next meeting.

Remember that flash mobs come in many different shapes and forms. There is no limit what can be done, be creative!
