

2012 Nebraska State Fair Campground Information and Request for Reservation Form

The Campgrounds are on the Fairgrounds property, but are outside of the Event fencing and thus do not require State Fair gate admission to enter the campgrounds. State Fair Admission tickets will be required of all exhibitor, vendors, concessionaires, and general public at all entrance gates of the Fair Event. Be sure you have or are prepared to purchase your entry ticket or daily re-entry hand stamp ready as you approach the ticket gates.

All campers are required to check in at the Campground office, pay any additional camping charges, and receive a lot location assignment. At check in, campground stickers will be furnished for cars. All vehicles without a sticker will be required to pay \$3 per night for camping. The Campground area is fenced with a permanent fence, and a Campground Manager is on duty at all times. The Manager will assign camping locations and will maintain a Campground directory.

CHECK IN: 3:00PM daily, CHECK OUT: 2:00PM daily, late check outs may be charged an additional day at the regular daily rate.

Free bus service will be available to and from the Campground. The bus will begin the route at 7:30 a.m. each day and will run every ½-hour until 11 p.m. The only boarding place for returning to the Campground is at the North Ticket Booth of the Fair.
