REQUEST FOR PROPOSAL

Official Livestock Photographer – NEBRASKA STATE FAIR

Nebraska State Fair (NSF) is seeking a qualified Livestock Videographer to provide labor, video equipment and streaming platform for exhibitors for the Nebraska State Fair.

About the Nebraska State Fair: The Nebraska State Fair, entering its 154th year in 2023, is an event held at Fonner Park in Grand Island, Nebraska. The regional event is a well-attended with having multiple livestock shows for the 11 day duration of the Fair drawing exhibitors from multiple states to compete for competitive cash prizes and bragging rights.

2.0 OVERALL SCOPE

- 2.1 **Term:** The contract will become effective upon signing through the conclusion of the 2025 Nebraska Sate Fair.
- 2.2 **Other Agencies:** Any other agency facilitating business with NSF, including Fonner Park and its partners, Aksarben Stock Show, or the Grand Island Livestock Complex Authority and its partners, shall not be bound by any agreement made as the result of this request for proposal.
- 2.3 **Agreements Made:** NSF may accept a proposal as written by issuing a written Agreement with the selected production agency. This agreement will be signed by both parties.
- 2.4 **Exceptions:** Any exceptions to any piece of this RFP shall be noted on the Proposal Addendum, Attachment A, and submitted.
- 2.5 **Contracts:** To be executed between NSF and Videographer Agency. All contracts shall be executed by the NSF Livestock and Equine Manager.
- 2.6 **Responsible Parties:** NSF final decisions on all Livestock Videographer decisions will remain with the Livestock/Equine Manager, Agriculture Director and in cooperation with the Executive Director and upon consultation with Photography Agency.

2.7 **Onsite:** This contract will require the chosen agency to have an onsite lead.

3.0 CONDITIONS

3.1 **Laws:** Terms and provisions of this solicitation and any agreement resulting from this shall follow any governing law applicable to this process. Any litigation or actions in connection with this proposal and subsequent award shall be instituted in the appropriate Nebraska courts.

3.2 **Assignment:** Any contract resulting from this solicitation may not be assigned, transferred, or delegated in whole or in part by the videographer, without the prior written consent of NSF.

3.3 **Termination:** NSF may terminate any agreement made as a result of this process at any time that the agency fails to carry out the provisions under the agreed-upon terms.

3.3.1 Upon termination, NSF shall provide written notice within 10 days of termination. Any monies owed to NSF shall be due within 30 days of written notice, and vice versa.

3.4 **Indemnification:** NSF hereby agrees to indemnify and hold harmless *Awardee*, as well as their agents, representatives, and directors from and against any loss, damage or expense associated with a claim arising out of the negligence of NSF. *Awardee* hereby agrees to indemnify and hold harmless NSF for any loss, damage or expense associated with a claim arising out of the negligence of the *Awardee*. The attached Proposal Addendum – Attachment B details the specific requirements.

3.5 **Retention of Rights:** The Awardee shall not have any rights to use the name, logos, trademarks or copyrights of NSF outside of the purposes of promotion related to NSF, without written permission.

3.5.1 NSF reserves the right to not award this offer to any Videography agency based on any reason.

4.0 SCOPE OF WORK

4.1 Agency will provide Stream for 4 species of livestock shows happening on two separate weekends (First weekend Sat/Sunday and Second Weekend Friday/Saturday/Sunday/Monday on Labor Day) and Open class Beef show occurring on Wednesday and Thursday during fair. There is the potential of streaming additional shows, depending on staff availability and cost.

4.2 Agency shall provide an avenue to stream Livestock shows.

4.3 Agency will be responsible for travel for their staff. NSF will cooperate with making lodging arrangement.

4.4 Meals within a reasonable allotment will be provided to labor for the duration of the livestock shows.

4.5 Nebraska State Fair will provide a Room to set up equipment and operate out of.
