# Meeting Minutes Friday, March 17, 2023

The annual meeting of the Nebraska State Fair Board was held on Friday, March 17, 2023, at 1:00 pm at the Nebraska State Fair Administrative Offices in Grand Island, NE. Public notice of this meeting was published in the Grand Island Independent newspaper on March 10<sup>th</sup> & 11<sup>th</sup>, 2023; posted to the Nebraska Public meeting calendar website; and on the Nebraska State Fair website. The public was invited to attend in person.

# Marketing & Sponsorship Report by Shirley McCallum for Ray Massie

- Sponsorship sales through the end of February almost at halfway point with \$458,540 collected.
- Current invoices \$102,000 for march (so far). Anticipate higher number as proposals are being renewed and contracts issued.
- NSF Core Values included on proposals to keep top of mind for staff and sponsors.
- Continuing to seek out new business partners locally, statewide, and nationwide.
- Keeping outside event tent busy during 2023 Fair is one of our goals.
  - Ideal for sponsors and local businesses
  - o Team building event, business meeting or customer thank you reception.
  - Class or large family reunions at the Fair with nearby outdoor game area.
- Early gate admission and wristband ticket sales robust 68% increase over 2022.
- Announcement of 2023 Concert Lineup coming in April.
  - o Performers have been confirmed.
  - Radio presenting stations have been selected.
- Move to new email provider and its integration with Etix.
  - o Increase of 12,000 addresses to our database
- Billboards for Eastern Nebraska to attract urban Nebraskans as well.

  - o Next step paint according to color-coded districts

- Accompanied Ag team at Oklahoma Youth Expo they had no wheelbarrows.
  - NSF has just increased our wheelbarrows by 30 for total of 63.
- Currently cleaning up outside shop and 2022 shade procurement.
- Also seeking more shade structures.

#### Sales Report by Holle Evert

- State Fair Cares Program
  - Non-profit organizations across the state have been given opportunity to have a complementary booth.
  - Application can be found on our website.
  - o Will select a committee (a few Board members will be asked to participate).
  - Will select 3 (1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place) to participate on two weekends and a weekday.
  - o Will select location with abundant foot traffic for most attention.
  - o A cash award will be given in addition to complementary space.
  - Application went live this week and we already have an applicant.

- Vendor Update
  - Offers went out yesterday for space that we have available in Expo Center.
  - Expo Center will be full, and we have opportunity to bring in a few new vendors.
  - We are placing about ½ of the vendors from the Fieldhouse in the Expo Center for 2023, and other half will be in the Nebraska Building on the first floor.
  - New layout for the northern part of the Outdoor Marketplace.
- Sustainability Pavilion will look a little different.
  - o More seating in that area
  - o Looking for vendors to fit "Family Friendly" theme.
- Ag Marketplace
  - o New vendor reached out with new product.
  - o Old vendor returning
  - o Actively recruiting food vendors.
- Communication committee meetings scheduled for next Thursday.
  - o Commercial Exhibits
  - o Concessionaires
  - Opportunities for NSF to learn from vendor's feedback.
