# SPECIAL RULES

- 1. General Rules and Regulations and Health Requirements apply to this division as well as those rules listed below. By entering the exhibitor agrees to abide by the Nebraska State Fair General Information Rules and Regulations, Equine Information Rules and Regulations. The exhibitor also agrees to abide by the IAFE National Code of Show Ring Ethics.
- 2. An open blank check will be required at the show office at cheek-in to cover added classes and will be returned at check-out if not classes added.
- 3. Stall assignments will be made by the Superintendent. In the case of a shortage the Superintendent will have the right to reassign pens, tack pens, etc.
- 4. All horses occupying stalls must pay a stall fee, whether entered for competition and judging.
- 5. Complete the stabling list for all owners and exhibitors who wish to be stalled together.
- 6. Assigned stall chart will be posted.

# FEED AND BEDDING

Exhibitors will be permitted to bring onto the grounds a limited amount of feed, hay, and bedding. If you wish to purchase hay, feed, and bedding from the fair you can purchase it from Aurora Cooperative. You can pre-order feed and additional bedding by contacting Aurora Cooperative at 308-750-6653. You can also visit their feed store during the State Fair.

## REQUIRED CREDENTIALS

The following documentation is required to show in the Nebraska State Fair NEAFQHR Horse Show. These documents will be checked upon your arrival at the Nebraska State Fair Equine Show Office.

- a. A copy of the registration papers for each horse. All horses must be registered. Pending registrations will be accepted only on foals of the current year if breed association rules permit.
- b. A copy of your FQHR membership owners and riders.
- c. A copy of your NEAFQHR membership owners and riders.
- d. A copy of your Amateur Certification, if applicable.
- e. Current Health and Coggins papers as outlined in the premium book.

## **SHOW RULES**

- 1. Classes will be governed by the rules of General Equine Information, Rules and Regulations. Foundation Quarter Horse Registry, and the Nebraska Affiliate Foundation Quarter Horse Registry. By signing the entry form the exhibitor agrees to abide by the rules and regulations of The Nebraska State Fair. Exhibitor also agrees to abide by the International Association of Fairs and Exhibition National Code of Show Ring Ethics found in the Equine Rules and Regulations Handbook and in the front of the premium book.

- 3. The rule book can also be viewed or downloaded and printed from the FQHR website: fqhr.net. Look under the Forms and Resources link.
- 4. Horse(s) must be entered in name of owner(s).
- 5. Youth exhibitors shall be 18 & under as of January 1 of the current year.
- 6. If the size of class warrants, eliminations may be held at the discretion of the management.
  7. Registration papers must reflect the current status of your horse. If your horse has been gelded, but you have not sent the papers in to reflect that, please do so immediately. Also, amateur and youth exhibitors can show horses belonging to themselves or an immediate family member. They may not show horses belonging to someone outside the family or in a ranch or corporation name, except in novice classes with a novice permit available at the
- 7. The 3-minute gate rule will be enforced. Plan accordingly.
- 8. All horses participating in the show, including herd holders and turn back horses must be FQHR registered and all participants, including herd holders and turn back riders and the owners of their horses must be members of FQHR and NEAFQHR.

# **AWARDS & PREMIUMS**

Over \$7000 in prizes will be awarded. 65 custom belt buckles will be awarded in all riding classes, along with Youth classes, including Grand & Reserve Halter classes. All Halter and In-Hand classes will receive awards, along with High Point and Reserve High Point in all divisions. Ribbons will also be awarded.
