Room was joined by Cindy Johnson with Grand Island Chamber of Commerce, Terry Galloway, 1868 Foundation Board Chair; Fonner Park Board Members: Pat O'Neill, Matt Maser, and Dave Hansen; Fonner Park Employee Mark Landis; Vince Fiala with Grand Island Casino Resort.

Discussion was led by Charlie Kolarik of Populous. 1868 Foundation and State Fair has asked to update the Master Plan and the room of stakeholders engaged conversation about any desired adjustments for future layouts and opportunities at Fonner Park Campus. Expo 2.0 is the one facility that has been added to the Master Plan, multiple locations were discussed for multiple surface improvements and garage parking options, equine barn and arena facility options were discussed, as well as land expansions, connecting walkways, and gateways onto and within the Fonner Park Campus.

Current and future ARPA (flood water mitigation) projects were discussed and recognized that ARPA projects are progressing with mindfulness of the master plan opportunity.

Potential funding for improvements were discussed.

Motion made by Boyd Strope to authorize the Executive Director to execute necessary agreements for Master Plan projects, and Master Plan funding as determined and approved by the facilities committee.
