The Nebraska State Fair is seeking qualified vendors to provide quotes to wrap our State Fair Vehicle Fleet.

Sealed bids will be received by the Nebraska State Fair until the due date and time, and then will be opened. The Nebraska State Fair adheres to State Transparency guidelines and reserves the right to share the final agreement details upon request.

Nebraska State Fair reserves the right to reject any or all quotations, to reject any bid that contains prices for individual items or services that are inconsistent or unrealistic when compared to other prices in the same or other bids, to waive any and all informalities and/or irregularities in the quotation, to negotiate and/or renegotiate with any vendor the terms of its quotation, and to accept any quotation which in its opinion may be in the best interest of Nebraska State Fair. This request does not commit Nebraska State Fair to pay any costs incurred in the preparation of a proposal or to procure or contract for service. Nebraska State Fair reserves the right to withdraw this Request in its entirety at any time without prior notice.

Each vendor's quotation shall constitute an offer to sell goods or services sought by this Request for Quotation. The award shall be made by execution of a contract mutually agreed upon by both parties.

SPECIFICS

Pricing: The bid price shown will be the full charge, inclusive of shipping charges and any other fees associated with the bid.

Invoicing: Unless otherwise stated, invoices are to be submitted upon completion of the job. The invoice must include an itemization of all items, supplies, repairs, or labor furnished, including unit list price, net price, warranty, and total amount due.

Payment: Unless otherwise stated, payment will be made within thirty (30) days of the completion of delivery of all items or services in acceptable condition to Nebraska State Fair and receipt of invoice, whichever is later.

Tax: Nebraska State Fair is exempt from Sales Tax and will supply a Form 13 upon award of the bid. Please quote less sales tax.
