

### Battle of the DJs: Sunday, August 31st

The Nebraska State Fair invites you to apply for Battle of the DJs as part of our festivities at the 2025 Nebraska State Fair. Join several talented DJs from around Nebraska for a chance to compete in this fun and exciting event, taking place on **Sunday, August 31**st **from 6-8 pm** on the Pump & Pantry Party Pit Stage.

A total of 6 DJs will be selected to perform a 12-15 minute set. Those selected to perform will receive two free gate admission tickets to the fair and a \$100 stipend for participation. The top 3 winners will also receive a trophy. Tickets given out for this event can only be scanned once, so please utilize them only on Sunday, August 31st.

The fair will provide a standard "club DJ setup," including a Pioneer DJ CDJ-2000NXS2, or something similar. DJs must bring their own DJ controller. More information about the setup will be provided when information packets are sent out.

If you are interested in applying to participate in this event, please fill out the attached registration form OR use the QR code below to complete an online application instead. Applications are due by July 1st, 2025. Do not leave any information on the application blank as the completed form aids us in providing you with an enjoyable experience! Please notify us immediately should any information on your registration form change.

- The parties agree that the Act, and any agents and employees of the Act, are acting in an independent capacity and not as officers, employees, or agents of the NSF.
- Act hereby waives all claims and recourse against the NSF Board, Fonner Park Exposition and Events Center, the
  Hall County Livestock Improvement Association, and the City of Grand Island, including the right to contribution for
  loss or damage to persons or property in any way connected to this Application and any subsequent Agreement, and
  shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, the Hall County
  Livestock Improvement Association, and the City of Grand Island from all claims due to any acts or omissions.
