## Important Dates

- Entry Deadline: Tuesday, August 5, at 11:59 pm
- Exhibit Delivery: Wednesday, August 13, 3 pm – 8 pm  
Thursday, August 14, 8 am – 3 pm
- Exhibit Release: Monday, September 1, 6 pm – 8 pm. **Early Release is Prohibited.**  
Tuesday, September 2, 8 am – noon.

Exhibits not picked up during the above designated times or with insufficient payment for return shipment must be retrieved from the Nebraska State Fair office, 501 E Fonner Park Rd, Ste 200, Grand Island NE 68801 by Friday, October 24<sup>th</sup>. After that, items will be donated to charity.

## Textile Arts Department Divisions

- Textile Arts is the use of fibers (plant, animal, & synthetic), yarns, or fabrics to construct practical or decorative items.
- Divisions 5201-5208 based on traditional textile art techniques and “new” trends. In most cases a pattern (beginning, intermediate, or advanced) guides the construction of the item.
- Division 5209 Junior & Senior Youth (ages 5-18) and Division 5210 Senior Adult (65 and older) offer classes for traditional techniques.
- Division 5211 Senior Living Communities.
- Division 5291 Best in County Contest. Each county may enter their one top county fair textile arts exhibit in the contest.

## Class Premiums and Overall Awards

The judge may but is not required to award all the placings offered in class. It is the intention of Fair Management that no premium or distinction of any kind be given to any exhibit deemed unworthy by the judge.

## Sweepstakes Sponsored by Grand Island Casino Resort

These are based on a point system. 1<sup>st</sup> place – 5 points, 2<sup>nd</sup> place – 3 points, and 3<sup>rd</sup> place – 1 point. Best of Show – 15 points, Reserve Best of Show – 12 points, Best of Division 10 points, Reserve Best of Division 7 points. Note: If an exhibitor wins for 2 consecutive years, they will be ineligible to win for the following 2 years.

1<sup>st</sup> place - \$300  
2<sup>nd</sup> place - \$200  
3<sup>rd</sup> place - \$100

The first-place winner will then go in for a people's choice Overall Sweepstakes Winner receiving a plaque and their name engraved on a trophy that will be displayed each year during the fair. The voting will begin the final weekend of the fair after all static events are complete. It will be a google form that you will use an email address to submit a vote.

## Department Rules

It's the Exhibitor's responsibility to be familiar with the [General Rules & Regulations](#) linked here which apply to all Nebraska State Fair open class departments of Competitive Exhibits and to the specific rules for each department.

### Additional Rules Specific to the Textile Arts Department are:

- All exhibits must be ready to be used by the individual or in the home. No unfinished exhibits will be allowed.
- Competition is limited to Nebraska residents only.
- With the exception of division 5291 (Best in County Contest), entry of item in a county fair is not a prerequisite.
- All items must be the work of one exhibitor, except for quilted by another person classes 0206, 0209, and 0211 in Division 5202 Sewing for the Home.
- All items must be clean, odor free, and in consideration of people with pet allergies free of pet hair.
- All work must have been completed in the last three years.
- Any item previously entered in the Textile Art Department may not compete again in Textile Arts.
- An exhibitor can enter up to two different items in the same class. The same item cannot be entered in more than one class.
- The exhibitor selects the division and class for entry. However, the superintendent may move an item to a different class to comply with the class description.
- Youth and Senior Adults may enter an item in Division 5201-5208 or in their respective age-restricted Division but

not the same item in both places.

- Birth date is required on the entry form for age-restricted classes only (Division 5209 & 5210). Enter appropriate class based on exhibitors age as of January 1<sup>st</sup>, 2025.
- Entries using commercial patterns, portions of commercial patterns, or replications of other's work are not considered original designs.
- Label exhibits with name and contact information.
- Information cards (3"x5", 4"x6", or 5 1/2" x 8 1/2") give the judge details to help them fairly evaluate an exhibit.
- Whether a card is optional or required will be noted in each division. Entries being considered for a ribbon placing without a required information card will be lowered one placing.
- Do not include newspaper articles and county ribbons. Include photographs only when requested.
- Removal of items prior to release time set by the Nebraska State Fair is prohibited and will result in the loss of premiums.
- Sewing from Home – all items must be made of three layers (top, filling, back) held together with thread, string, or machine quilting that goes through all three layers. Any item with a design that makes it suitable for a wall hanging will not be acceptable in Textile Arts and will need to be entered in the 3-layer wall hanging division in the Quilts Department.

## **Entering Exhibits – The deadline is Tuesday, August 5, at 11:59 pm.**

Exhibitors may purchase \$5 Exhibitor Gate Tickets. A maximum of 5 exhibitor tickets per family is allowed. No refunds will be given on any unused or lost tickets. To purchase these tickets, go to <https://bit.ly/3DdaaKm> and use password CVENT. Exhibitor tickets go off sale Thursday August 21, 2025 at 11:59pm.

**Online Registration:** The most time and cost-efficient way to enter is online. Exhibitors can enter all their open-class exhibits and order exhibitor tickets (optional) in one session. Online entry begins around July 1. **Mail-In or In-Person Registration:** When using mail-in or in-person registration, the exhibitor must use a separate form for each department entered. ## **Guidelines for Completing Entry Form**

- Enter all items you plan to bring. There is no entry fee. Items not brought will be deleted at the fair.
- Provide a description that gives identifying details to help locate the entry on sight. The description must not exceed 40 characters (letters, numerals, and spaces). Examples of suitable descriptions are listed under each division/category heading.
- Indicate plans for delivery and pick up of entries.
- Retain a copy of the entry form. A copy is required with each package mailed/shipped. For online registration: print either the entry receipt activity report or a packing/loading report. Package exhibits by department it is entered in. Do not package multiple departments together.

## **Delivery of Exhibits – The deadline is Thursday, August 14, at 3 pm**

In Person: Deliver exhibits along with a copy of the entry form to the Textile Arts Department located in the 4-H FFA Fieldhouse. Use Gate 5 and you can enter the North or West doors.

There are two receiving dates this year: Wednesday, August 13, 3 pm - 8 pm, and Thursday, August 14, 8 am – 3 pm.

Ship by USPS, UPS, or FedEx: Refer to the [Shipping Options](#) for detailed instructions on packaging and where to send exhibits. A prepaid return label must be included if you wish for it to be shipped back.

## **Return of Exhibits – Early release is prohibited.**

In Person: Items can be picked up Monday, September 1, 6 pm – 8 pm or Tuesday, September 2, 8 am – noon. You must sign the release list to collect your textile arts entries. If you mailed or shipped exhibits but wish to pick them up in person at the end of fair, you may do so with identification.

Shipping: Exhibitors who want items returned by mail or delivery service must make this notation on the entry form enclosed with exhibits. Exhibits will not be accepted or returned by COD. Refer to [Shipping Options](#) for return information.

# **Divisions 5201 - 5211**

## **Division 5201: Sewing for Children and Adults**

Garments, Accessories, and Toys.

### **Guidelines:**

- Hang garments on a sturdy hanger. Place small items in a zip type bag
- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.

### **Include**

- Pattern/designer and/or kit
- Materials used
- Did you adapt the pattern, if so what did you do?

### **For Children**

Examples of descriptions: (1) pink kitty puffy sleeve dress or (2) brown floppy eared furry dog

- 0101 Dress or Jumper
- 0102 Dress: List specific occasion
- 0103 Jacket or Coat
- 0104 Outfit (2 or 3 pieces)
- 0105 Accessory
- 0106 Toy, Stuffed Animal, or Doll
- 0107 Doll Wardrobe (2 or more outfits)
- 0108 Children's Party Clothes
- 0109 Other Technique, not listed

### **For Adults**

Examples of descriptions: (1) red lace halter top, long/chiffon/skirt or (2) reversible blue daisy print sun hat

- 0111 Dress or Jumper
- 0112 Dress: List specific occasion
- 0113 Outfit (2 or 3 pieces)
- 0114 Jacket, Coat, or Suit
- 0115 Apron
- 0116 Bag or Purse
- 0117 Hat
- 0119 Other Technique, not listed

## **Division 5202: Sewing for the Home**

Three-layer, two-layer, computerized machine embroidery, other

### **Overall Division 5202 Guidelines:**

- Bed Runner: any length, maximum width 36 inches
- Exhibit must be a decorative or functional item for the home. Unless otherwise indicated the process should involve use of a sewing machine and/or serger.
- The work on the exhibit should be done by the exhibitor except for classes 0206, 0209, and 0211, machine quilted by another person.
- Embellishments such as decorative sewing machine stitching, buttons, and trims may be added.
- Hand stitches may be used for finishing or quilting.
- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.

### **Include**

- Pattern/designer and/or kit
- Materials used (fabric, batting, thread)
- Did you adapt the pattern, if so what did you do?

### **Three-Layer Category**

Examples of descriptions: (1) 22x28 fall print log cabin MQ runner or (2) 4 strip-pieced batik MQ placemats

All items must be made of three layers (a top, a filling, and a back) held together with thread, string, or machine quilting that goes through all three layers. Any item with a design that makes it suitable for a wall hanging will not be accepted in this division. Enter three-layer wall hangings in the Quilt Department.

### **Guidelines:**

- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.
- For classes 0201-0206 select or design a pattern specifically for a long and narrow table runner. After the pattern if the item could be a wall hanging – for example, add triangles or half circles on both ends, alter direction of one-way blocks, or add another design feature that makes the design unsuitable for a wall hanging.
- Table runners must be a minimum of 20" in length and a maximum of 30" in width.
- A circular, square, or hexagonal topper must be a minimum of 14" in width (diameter or point to point).
- Three-layer category is for two-dimensional (length and width) items. Three-dimensional items (length, width, & depth/height) should be entered in miscellaneous category class 0249.
- From a design perspective any item that could hang on a wall will not be accepted.

0201 Table Runner, pieced

0202 Table Runner, pieced/appliqued

0203 Table Runner, with die/laser cut applique

0204 Table Runner, with computer machine embroidery/stitches

0205 Table Runner, with hand embroidery

0206 Any Table Runner, quilted by a 2<sup>nd</sup> person. Include person's name on information card

0207 Table Topper, pieced

0208 Table Topper, with die/laser cut applique

0209 Table Topper, quilted by a 2<sup>nd</sup> person, include person's name on information card

0210 Bed Runner

0211 Bed Runner, quilted by a 2<sup>nd</sup> person, include person's name on information card

0212 Set of Items for the Kitchen, e.g., set of placemats (2), potholders (2), tea towels (2), or hot dish mats, casserole cover (1), or other item (2)

0213 Christmas Tree Skirt

0219 Other Technique, not listed meeting all guidelines

## Two-Layer Category

Example of a description: 60x70 recy/denim/patch/red back/tied

This category is for two-layer items, a front and back with no filling. Items include blankets, throws, coverlets, and wall hangings which may be held together with thread, string, or machine quilting. Backing may be flannel, minkie, fleece, or other. Computerized machine embroidery will also be accepted in two-layer category. Two-layer tied fleece blankets will not be accepted. See division 5208 Fiber Arts for wool/wool felt items.

### Guideline:

- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.
- 0221 Item using heavy material, e.g., jeans, denim, corduroy  
0222 Item using lightweight material  
0223 Item using knits, terry cloth, e.g., t-shirts, golf towels  
0229 Other technique, not listed

## Computerized Machine Embroidery

Examples of descriptions: (1) duck app on blue infant t-shirt, (2) happy snowman on white towel

### Guidelines:

- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.

### Include:

- Design/pattern source
- Any editing of the design including changes in thread color
- Stabilizer(s) used
- Kind of thread
- Item, ready-made or constructed by exhibitor
- Other pertinent information
- Embroidery designs, sometimes called patterns, are created by a technique called digitizing. Embroidery designs/patterns can be purchased or created by an exhibitor with embroidery digitizing software.
- Classes 0231-0237 are for items embellished using a computerized sewing-embroidery machine. The item may be ready-made or constructed by an exhibitor.
- When a computerized embroidery design is combined with other techniques the item should be entered in the appropriate division/class. For example, a quilted table runner combining fabric blocks with computerized embroidered blocks should be entered in the 3-layer category (class 0204).

- 0230 Table Runner, embroidery only  
0231 Table Runner, applique or embroidery  
0232 Table Topper, embroidery only  
0233 Table Topper, laser cut or Cricut cut applique and embroidery  
0234 Wall Hanging, small, embroidery only  
0235 Wall Hanging, small, applique and embroidery  
0236 Wall Hanging, large, embroidery only  
0237 Wall Hanging, large, applique and embroidery  
0238 Tea Towels, 2 or more  
0239 Clothing Article  
0240 Accessory  
0241 Original Design on Item, digitized by exhibitor  
0242 In-the-Hoop Item, e.g., key chains, tags, small bags, towel toppers, or stuffies  
0243 3-D Items constructed totally from computer machines embroidered components  
0244 Item using Computerized Embroidery Kit  
0245 Other Technique, not listed

**Miscellaneous Category** – for items that do not fit in any of the above classes 0201-0244

Examples of descriptions: (1) 16x38 pillow w/pre-cut valentine app or (2) oval coiled pastel basket w/handles

- 0261 Pillowcases, pair with cuff
- 0262 Decorative Stuffed Animal/Doll
- 0263 Pillow
- 0264 Pillow, with die or laser cut applique
- 0265 Fabric Basket, any size, any technique
- 0266 Fabric Basket, no handles, any size, any technique
- 0267 Accessory made from Jelly Roll
- 0268 3-D Item, minimum of 16" in diameter or point to point. A 3-dimensional item has width, length, and depth/height. (i.e., the fold'n stitch wreaths, centerpieces, or toppers)
- 0270 Other Technique, not listed

## **Division 5203: Crochet**

### **Guidelines:**

- Crocheted items using plastic or non-fiber material should be entered in Visual Arts.
- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.

### **Include:**

- Fiber content of yarn(s) and % of reach
- Hook size
- Gauge
- Weight of yarn
- Pattern stitch
- Other pertinent information
- Yarn may be one color, variegated, or two or more colors
- Beads may be incorporated into any item
- All items crocheted then felted, should be entered in Division 5207 Weaving, Spinning, & Felting

### **Garments**

Examples of descriptions: (1) child blue/hooded/jacket w/buttons or (2) gray men's vest w/blue/trim/buttons

- 0301 Infant or Child's Garment
- 0302 Adult's Jacket, Sweater, or Vest
- 0309 Other Technique, not listed

### **Accessories**

Examples of descriptions: (1) sc blue socks w/red/toe/heel/cuff or (2) 70" royal blue chevron lace scarf

- 0311 Infant or Child's, 2 or more articles, e.g., bonnet, hat, cap, booties, shoes, or other
- 0312 Shawl, Stole, Shrug, Poncho
- 0313 Hat, Cap
- 0314 Headband or Warmers (ear, arm, neck, or leg)
- 0315 Gloves, Mittens
- 0316 Socks, Slippers
- 0317 Scarf
- 0319 Other Technique, not listed (if small, minimum of 6)



## **Afghans/Throws**

Examples of descriptions: (1) 60x72 multi-color granny square afghan or (2) 30x40 red ribbed wh-chair lap robe

- 0321 Child Afgthan/Throw
- 0322 Adult Afghan
- 0323 Throw, Lap Robe
- 0329 Other Technique, not listed

## **For the Home**

Examples of descriptions: (1) ecru lacy/thread 12 in doily or (2) gray puff/diamond pillow cover

- 0331 Kitchen Group, minimum of 3 items
- 0332 Doily or Centerpiece, up to 10" in diameter, single stitch type
- 0333 Doily or Centerpiece, up to 10" in diameter, multiple stitch type, list stitches on information card
- 0334 Doily or Centerpiece, 11-18" in diameter, single stitch type
- 0335 Doily or Centerpiece, 11-18" in diameter, multiple stitch type, list stitches on information card
- 0336 Doily or Centerpiece, over 18" in diameter, single stitch type
- 0337 Doily or Centerpiece, over 18" in diameter, multiple stitch type, list stitches on information card
- 0338 Table Covering, 24" or more in diameter
- 0339 Bed Linens, such as spread, coverlet, bed runner
- 0340 Bed Accessories, such as pillow, pillowcases (2), shams (2)
- 0341 Crocheted Edging attached to an Item, 1 inch or wider
- 0342 Doll or Doll Group, must use purchases figure(s)
- 0343 Animal or Animal Group
- 0344 Other Technique, not listed

Example of a description: powder blue knook scarf

## **Division 5204: Knitting**

Hand knitting, lace knitting, advanced pattern, and other

### **Guidelines:**

- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes.

### **Include:**

- Fiber content of yarn(s) and % of each
- Needle/hook size
- Gauge
- Weight of yarn
- Pattern stitch
- Other pertinent information
- Yarn may be one color, variegated or two or more colors
- Items that are predominately (75% ore more) lace knitted should be entered in the lace knitting (LK) classes unless they are made using an advanced pattern technique (AP).
- All items knitted then felted should be entered in division 5207 Weaving, Spinning, & Felting
- Abbreviations:
  - HK: Hand Knitting with needles (flat or circular)
  - LK: Lace Knitting characterized by stable "holes" arranged with consideration of aesthetic value
  - AP: Advanced Pattern e.g., Fair Isle, Scandinavian, Intarsia, Argyle, color work, short rows, entrelac

## **Garments**

Examples of descriptions: (1) HK ch's pink pullover w/cf celtic braid or (2) LK 6x60 scarf lace ribbon pat w/beads

## **Division 5205: Lace Making**

Bobbin lace, tatting, other lace

### **Guidelines:**

- Beads may be used in any of the lace designs.
- Handmade lace embellished garments or accessories should be entered in division 5208 Fiber Art.
- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes. Attach to entry (may be displayed with entry).

### **Include:**

- Pattern/design source
- Materials used i.e. needle and/or shuttle size, thread, etc

### **Bobbin Lace**

Example of description: 2x8 pink BL bookmark/hearts/tassel

- 0501 Bookmark
- 0502 Motif or Lace Corner
- 0503 Round or Oval Item
- 0504 Jewelry, e.g., earrings, bracelet, necklace
- 0505 Picture – framed and/or matted
- 0509 Other Item, not listed

### **Tatting**

Examples of descriptions: (1) tatted/beaded red dangle earrings or (2) tatted white cross, blue bkgd, framed

- 0511 Bookmark
- 0512 Motif Work – repeated design within pattern
- 0513 Picture, framed and/or matted
- 0514 Round or Oval Item
- 0515 Jewelry, e.g., earrings, bracelet, necklace

## **Division 5206: Stitchery**

Hand embroidery, counted cross stitch, needlepoint, and other types.

### **Guidelines for all stitchery classes:**

- All exhibits must be ready to be used by the individual or in the home. No unfinished exhibits will be allowed.

- Classes for computerized machine embroidery are in division 5202 Sewing for the Home classes 0231-0244.
- Information card (3"x5", 4"x6", or 5 ½" x 8 ½") required in all classes. Attach to entry (may be displayed with entry).

### **For classes 0601-0629 and 0641-0649 include:**

- Pattern name and/or designer
- Fabric or other base for stitching, thread, and other materials used

- Techniques used
- Other pertinent information that talks about the piece and how it was created

## **Division 5208: Creative Fiber Art Techniques (CFAT)**

**Creative Fiber Art Techniques**

Creative fiber art is the work of someone who likes to “journey outside the box” by going beyond the suggested pattern instructions, drawing on past experiences with a variety of techniques and finding ways to use these techniques in non-traditional ways. The end result is often a one-of-a-kind item that is aesthetically pleasing. Upcycling, popular now, offers many opportunities for creating unique fiber art.

To decide where to enter an item (traditional class in other divisions or in division 5208 Fiber Arts) ask yourself, “would my exhibit look “out of place” with traditional exhibits?” If yes, review the following guidelines before making a final decision.

**Guidelines:**

- Items can be made from non-usable textile items, new materials, or a combination of both.
- The visible part of the item must be at least 75% textile and no more than 25% non-textile media like plastic, glass, wood, metal, & paper except diamond art on canvas.
- At least two techniques beyond the “basic construction” techniques should be used.
- Fiber pictures or other items for the wall must include a feature(s) that make(s) the exhibit unacceptable in the quilt department – such as sharp embellishments, an attached hanging device (like a stick), lights with battery pack, or any rigid items that interferes with folding the piece.
- All items must be suitably finished and ready to display. Wall hanging should have a rod pocket or another method for hanging.
- The perimeter is the distance around the stitched piece – and does not include the width of the mat and/or frame or other display materials.
- Classes are listed by technique, not item. Items for possible use in CFAT are pillows, wall hangings, purchased or sewn garments, table runner/toppers, placemats, pictures, ornaments, etc.

**Information Story Required** (replaced information card)

- 1-2 page story will be displayed with the exhibit. Place photos (optional) in plastic bag. The story should include:
  - Materials and techniques used
  - Design source or inspiration
  - Name of piece (optional)
  - How item will be displayed
  - Description of the process used
  - Other pertinent information

## **Division 5291: Best in County Contest**

Counties are invited to participate in the Textile Arts Best in County Contest by selecting their top textile arts exhibit at the local county fair. Each county in a multi-county fair may have one entry.

It is the responsibility of the superintendent/another county official to determine how the selection will be made. Review the Textile Arts Entry Book to find out what exhibits are accepted in the Nebraska State Fair Textile Arts Department.

If the selection of the Best in County exhibit happens too late for the exhibitor to meet the deadline for entry of exhibit (August 6<sup>th</sup>, midnight) the county winner will be eligible for recognition the following year provided that the entry still meets the requirement completion within the last three years. Exception: if the exhibitor had already entered the item in the textile art department the entry is eligible for this year's Nebraska State Fair.

### **To participate in the Best in County Contest:**

1. Prior to the county fair the superintendent or another official should print the Textile Arts Entry book.
  - a. Two copies of this page – Division 5291, Class 9901, Best in County Textile Arts (copy for superintendent and copy for exhibitor).
  - b. One copy of [Best in County Textile Arts Verification Form](#)
    - i. Note: if you don't have an option for printing the forms you may request them from the Nebraska State Fair office.
2. Immediately following the county fair, complete the verification form which requires the signature of the superintendent/official and make two copies for the exhibitor. The exhibitor will:
  - a. Send one copy of the verification form to Sue Brown, Nebraska State Fair Textile Arts, 518 S Rhode Island, Hastings NE 68901. If the form will not reach Sue by Tuesday, August 6<sup>th</sup>, call Sue with the information 402-460-7988.
  - b. Attach a copy of the Verification Form to the exhibit.
3. Prior to Tuesday, August 6<sup>th</sup>, midnight entry deadline the Best in County exhibit must be entered in Textile Arts in the appropriate class in Division 5201-5210. The entry must comply with all Nebraska State Fair Textile Art restrictions and rules. Enter online or by using the Textile Arts entry form. Refer to the front of this entry book for details.
4. Delivery of Exhibit – Deadline is 3 pm Thursday, August 15<sup>th</sup>, to the 4-H/FFA Fieldhouse, Gate 5, using the North & West doors. Note: the receiving date is the same as all other textile arts entries in the 2025 Textile Arts Department, however the extension staff can pick up the exhibit at the end of fair.
  - a. Exhibit may be delivered by:
    - i. The exhibitor /another person during the Textile Arts receiving times Wednesday, August 14<sup>th</sup>, 3pm-8pm and Thursday, August 15<sup>th</sup>, 8am-3pm.
    - ii. Sending by mail or a delivery service with arrival not later than 3 pm on Thursday, August 15<sup>th</sup>. See [Shipping Options](#). Mail or ship no later than Tuesday, August 6<sup>th</sup> for items to reach the Nebraska State Fair by delivery deadline.
5. Display- all textile arts entered in the Best in County Contest are displayed in a designated area in the 4-H/FFA Fieldhouse. Best in County entries are noted with (1) signage acknowledging them as the top county winner in their respective county fair and (2) with a distinctive Best in County ribbon. Those receiving 1<sup>st</sup> through 5<sup>th</sup> place in the contest will also receive a special rosette in addition to the designated cash award.
6. Return of Exhibits – exhibits may be picked up on Monday, September 2<sup>nd</sup>, 6-8pm or Tuesday, September 3<sup>rd</sup>, 8am-noon by the exhibitor, another person, or extension staff. For other return options see [Shipping Options](#).
  - a. Note: Exhibits not picked up by the above options or with insufficient payment for return shipment must be retrieved from the Nebraska State Fair Office, 501 E Fonner Park Rd, Ste. 200, Grand Island NE 68801 no later than Friday, October 25<sup>th</sup>.
