

# NEBRASKA STATE FAIR BOARD Meeting Minutes Monday, September 1, 2025

The Regular meeting of the Nebraska State Fair Board was held on Monday, September 1, 2025 at 11:00 am at Nebraska State Fair Administrative Offices in Grand Island, NE. Public notice of this meeting was published in the Grand Island Independent newspaper on August 15 & 16, 2025; posted to the Nebraska Public meeting calendar website; and on the Nebraska State Fair website. The public was invited to attend in person.

#### 1868 Foundation Report by Terry Galloway

- The Great Steak Debate event saw great success.
  - Certified Piedmontese, Cargill and Tyson provided steaks for the event.
  - o A little over \$105,000 was raised.
- The VIP Donor Reception held during the State Fair was also well attended.
  - Many attendees had upgraded and joined the society.
  - o There was \$80,000 raised in 1868 Foundation commitments.
- The 1868 Foundation gift shop also saw \$34,000 in sales so far at this State Fair.
- Request was made that Nebraska State Fair Board and the 1868 Foundation Board consider planning a joint board meeting to discuss multi-year fundraising plans.
  - o Present State Fair Board members were in favor of this, but no official motion was made.
  - Discussion was had about potential meeting plans.

# **Executive Director Report by Jaime Parr**

- Enjoyment was expressed about the 2025 State Fair in light of it being the last day of the Fair.
- Gratitude was extended to board members who attended the morning's Veterans Program and greeted guests.
- Recognition was also made for John Skold a former, long-time Nebraska State Fair staff member who passed away shortly before this year's Fair.
  - He dedicated 44 years to the Fair and appreciation was shown for those years of service.
- State Fair data and performance trends were discussed.
- Fair weather was also discussed as recent rain made campus improvements evident.
  - Some projects are still in the works.
  - Upcoming meetings are scheduled with ARPA to discuss what projects can be done with the \$1.5 million funds approved by the State Fair Board.
- Praise given to Jaime Parr by Dawn Caldwell for strong leadership and to State Fair staff for quality collaboration this Fair season.
- It was noted that the coming meetings in October, November and December will focus on reviewing this year's events and preparing for those to come in 2026.
