The Nebraska State Fair invites your FFA involved youths to attend our **2026 FFA Day** at the fair, taking place on **Thursday, September 3rd** across the fairgrounds.

Admission is FREE for chapters that register for this event, intended as an educational, self-guided tour of the fairgrounds. Free admission will be provided for adult chaperones/sponsors at a 10 : 1 (student : chaperone ratio). Additional chaperones/sponsors beyond this ratio will be required to purchase full-price gate admission tickets. Gate admission is \$12 a person. Exact attendance numbers are not required upon registration and can be provided to the fair at a later date if necessary.

More information will be provided mid-summer, so it is important that you provide us with contact information and a current mailing address. Resource packets will be sent in July or early August. If you require additional tickets after registering, please reach out to the office as soon as possible.
