- This is only an application for an opportunity to perform. Submission of this application does not guarantee the applicant will be selected to perform at the NSF, nor does it constitute any agreement to provide space, services, or compensation.
- The parties agree that the Act, and any agents and employees of the Act, are acting in an independent capacity and not as officers, employees, or agents of the NSF.
- Act hereby waives all claims and recourse against the NSF Board, Fonner Park Exposition and Events Center, the Hall County Livestock Improvement Association, and the City of Grand Island, including the right to contribution for loss or damage to persons or property in any way connected to this Application and any subsequent Agreement, and shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, the Hall County Livestock Improvement Association, and the City of Grand Island from all claims due to any acts or omissions.
- Act shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, the Hall County Livestock Improvement Association, and the City of Grand Island, its officers, agents and employees from any and all claims, suits or actions of every name, kind and description brought forth from, or on account of, injuries to or death of any person including, but not limited to, workers and the public, or damage to property resulting from the performance at the NSF.
