1. Entries

- a. All Nebraska State Fair Livestock Entries are online at <https://www.statefair.org/ag-competitions/equine-exhibitors/>
- b. **Entry Fees (per day)**
 - i. \$100 for all Divisions per class per dog.
 - ii. Designated cattle dog exhibitor parking areas will require a parking pass to be purchased. This parking pass can be purchased when completing online entries or at the check-in trailer.
- c. All entries must provide proof of current rabies.

2. Special Rules

- a. General Rules and Regulations and Health Requirements apply to this division as well as those rules listed below. By submitting entry to the Nebraska State Fair exhibitor agrees to abide by these rules.
- b. The Trials will be sanctioned with:
 - i. National Cattle Dog Association
 - ii. Good Life Series
 - iii. Mountain States Stockdog Association
 - iv. Central Cattle Dog Association
- c. 2 dog per handler per class limit.
- d. In the event entries exceed the limit, the first dogs entered will be entered in the trials.
 - i. The average winners in Pro-Novice, Open, Intermediate, Nursery, and Novice will be determined by results over the two days earning a belt buckle.
 - ii. We will pay day money and will also award Grand Champion and Reserve Champion banners in each class.
 - iii. This will be a time and points trial incorporating Outrun, Fetch, Drive, and Pen Work.
 - iv. Top Average Finishers of all classes will qualify for a final shootout bracket on Saturday Evening.
 - v. The course and rules will be explained at the handlers' meeting immediately preceding each day's event.
